Demystifying the Bankline Direct Reporting Formats



A range of materials are available to support your transition to ISO 2022. This guide introduces the major differences between the current reporting formats and the go forward ISO Cash Management (Camt) format. Camt version 2 format is not highlighted in the following pages as it is like for like with the new compliant version 8.

Please use this guide to gain an initial understanding of the level and complexity of the changes required to allocate resources and complete a full impact assessment.
